### Our Hospital and the Community Served

#### About Virginia Mason Franciscan Health and St. Elizabeth Hospital

Virginia Mason Franciscan Health is a nonprofit health system with over 300 sites of care, 11 top-tier hospitals, 18,000 team members, and over 5,600 physicians and advanced practice providers throughout the Puget Sound region.

St. Elizabeth Hospital is a 25 bed critical access hospital in Enumclaw, WA. St. Elizabeth employs over 200 employees and, in Fiscal Year 2022, generated over 5,000 inpatient days and over 12,000 emergency room visits. Community benefit, the cost of charity care, uncompensated care, and community programs, totaled over \$3 million in 2022.

#### Our Mission

St. Elizabeth Hospital's dedication to assessing significant community health needs and helping to address them in conjunction with the community is in keeping with its mission. As CommonSpirit Health, we make the healing presence of God known in our world by improving the health of the people we serve, especially those who are vulnerable, while we advance social justice for all.

#### Financial Assistance for Medically Necessary Care

St. Elizabeth Hospital delivers compassionate, high quality, affordable health care and advocates for members of our community who might have difficulty accessing and paying for necessary medical care. In furtherance of this mission, the hospital provides financial assistance to eligible patients who do not have the capacity to pay for medically necessary health care services, and who otherwise may not be able to receive these services. #### Description of the Community Served

St. Elizabeth Hospital is located in Enumclaw, WA. A summary description of the community is below. Additional details can be found in the CHNA report online.

King County has over 2.1 million residents and covers over 2,300 square miles. The community is increasing its racial and ethnic diversity. The population of children under 18 is now 53% people of color. One in four King County residents live in a household where a language other than English is spoken.

Although poverty rates are declining in Seattle, King County, and Washington state, disparities persist by race, place, and disability. One in five King County residents live in poverty or near poverty. More than 38% of young adults (18-24) and nearly half of Black and American Indian/Alaska Native residents live below 200% of the federal poverty level. Over 35% of King County youth are eligible for free or reduced price lunch.

### Significant Health Needs

The CHNA identified the significant needs in the table below, which also indicates which needs the hospital intends to address. Identified needs may include specific health conditions, behaviors and health care services, and also health-related social needs that have an impact on health and well-being.

Behavioral Health	The CHNA calls out residents dying from unintentional injuries related to poisoning (by both legal and illegal substances).	Yes
Chronic Disease	The CHNA points to concerns around obesity, cancer, diabetes, and hypertension.	Yes
Access to Care	Communities of color continue to be disproportionately uninsured.	Yes
Food Security	There was a large jump in food insecurity among Black residents before the onset of the pandemic.	Yes
