Virginia Mason verifies the identity and work eligibility of every new employee via the Federal Form I-9 and inputs each person's information into the Department of Homeland Security's E-Verify system.

This page outlines the type of documentation required to validate your identity and work eligibility. New employees are required to bring:

One identifying document from LIST A

OR

A combination of one selection from BOTH LIST B AND LIST C

You are required to bring this/these documents with you on your first day of employment.

In addition to the Form I-9 requirements, the Department of Homeland Security's E- Verify system requires:

- Your documentation is current not expired
- If you present a List B document, it must contain a current photo
- If you are a permanent resident,0 you must provide your Alien Registration/USCIS number on the I-9 (found on your Form I-551)

You are asked to complete Section 1 of the Form I-9 now, and it will be reviewed along with your identification documents on your first day. Employment at Virginia Mason is contingent upon completing and signing an I-9 form on your first day of employment including providing acceptable documentation.
